



Covid-19 Informations

With the latest government announcements, we need to adapt and implement new rules related to the Covid-19 health crisis

From the date of publication of the future decree (which should be in the first week of August), access to our campsite will be probably subject to the **presentation of a Health Pass valid, for anyone 18 years and older**. For security, please plan it **from the 01st of August**.

This is a new constraint, but fortunately limited because our Federation has obtained that this Health Pass **is valid for your entire stay**.

In practice, if you have give your Health Pass at your arrival, you will be able to access the restaurant or the pool throughout your stay whether it is 2 days or 2 weeks

As a reminder, the Health Pass is issued in 3 cases:

- **Vaccination** has been carried out, provided that people have a complete vaccination regimen
- Evidence of a **negative test of less than 48 hours**.

All RT-PCR and antigenic tests generate evidence as soon as the result is entered by the health professional.

Please note that the cost of these tests is about 25€ for foreigners and can be carried out in 15min in all pharmacies including on your road to come or arriving on Barcelonnette or Sauze.

- The result of a positive RT-PCR test demonstrating **recovery from Covid-19**, at least 11 days old and less than 6 months old.

We know that this is complications for your holidays, so we want to inform you as soon as possible so to simplify your organization.

Note that we will keep all the health measures already in place and described below.

Camping is certainly the **safest mode of vacation** in these **troubled times**: you are almost all the time **outdoors!**

At **La Chaup campsite** our pitches are large enough (80m²) to guarantee you a sufficient **social distance** while maintaining **a conviviality** that we missed during this confinement.

And as you come with **your vehicle** and **your personal camping equipment**, or you rent **un private accommodation**, the risks are **greatly reduced if everyone complies with the barrier measures**.

We attach a **very special attention** to this last point, whether in **the reception, in the snack bar or in the sanitary facilities**.

So as you are certainly **looking forward to camping** and escaping after these months of confinement, you will find below many **answers to your questions**.

We would like to remind you that **we do not yet have all the information**. Therefore, these responses can be adapted to the current situation and we will update this **document regularly**.

How has the campsite adapted to this exceptional situation?

First of all, we inform you that the campsite will implement in 2021 as during the 2020 season **all the health and social measures recommended by the government and our federation**.

At your arrival, the Reception is accessible **only for one person or family at a time**, with wearing of **the mask mandatory**.

We have **increased the number of outdoor dishes and linens sinks** to ensure distancing.

Soap dispensers and disposable hand towels are placed near the washbasins to allow for regular hand washing...

The sanitary facilities are cleaned **twice/day**, and we pay even greater attention to **disinfecting** with suitable products **all the parts that are conducive** to the spread of the virus.

In these the wearing of **the mask is mandatory** and we pay special attention to it.

As almost all of the interior installations are **in cabins**, customers only cross each other greatly reducing the risk of propagation.

Our **rentals** are completely **cleaned and disinfected** between 2 customers. Bedding and pillows/duvets are equipped with **single-use covers**, of course completely changed between each stay.

The counter of **our Snack is outside**, with obligation to respect a safe distance. The consumption is done **in terrace**, with a low density of tables in order **to respect the minimum distances**.

What is the opening date of La Chaup campsite?

To date, the opening date is **29 May 2021**. This opening date may **change depending on changes in the health situation** and government decisions specific to our activity.

You want to make a reservation, but you are afraid you won't be able to come?

You have two options:

- You will be able to obtain a **Credit Note** if the health situation related to Covid prevents you from visiting our campsite, **valid for 18 months**.

If you request the cancellation of your stay without acceptable proof, then our usual terms and conditions will apply (full terms and conditions on our website).

- An optional **Cancellation Insurance** from our partner **CampezCouvert** is available (full description on our website). It covers **Covid-related risks**, in addition to the usual guarantees and for a relatively small amount.

If you are required to enforce Covid-related coverage, **we will reimburse you for any deductibles**.

The influx will undoubtedly be even **more important** this summer in our beautiful valley of the Ubaye to come and **enjoy the wide open spaces and the sun**.

Do not delay to make your reservation in all serenity to guarantee you a place this summer at the **campsite La Chaup**.
